INSTRUCTIONS FOR COMPLETION OF EPA ID CARD REGISTRATION FORM

Failure to complete the form correctly will result in the form being returned.

JUNIORS: These are persons who are UNDER 18 Years old on the 1st January on the year of Application.

ALL APPLICATIONS: Must be completed correctly, in Block Print and must be accompanied by the relevant fees.
If you are transferring from another County Association please speak to your new County Secretary reference filling in a transfer form. Section 6 of the ID Registration of ID members.

ID PHOTO'S: All Relevant applications must be Accompanied by two (2) passport sized photos, meeting the criteria / examples below:
The Photo's should fit within the grid on the Application and should be between 25mm & 35mm when measured from the top of the hairline to the bottom of the chin.
If Printing your own Photo's they Must be supplied on Photographic Paper (plain paper can stain when mounting Photo's).

Renewals: All Shaded boxes to be completed (EPA ID Number to be inserted.)
Junior & Senior If Junior Application then the form **MUST BE COUNTERSIGNED** by Parent/ Legal Guardian.

Change of Details:
Junior To Adult: As per **new application** + old card must be returned.
Name/Address Change etc: As per **new application** + old card must be returned.

Replacement Cards:
Loss of Photo Card: As per new application.
Loss of Year Card: As per renewal.

RETURNING FORMS

Within County Structure: Return to person named on form / County Registration Official.
if county registration official: Return to your Region Registration Official.

ALL CARDS

All Cards: MUST be laminated

Photo ID Cards: Front - MUST have players Photo plus the Regional Registration Officials signature & date of issue and the E.P.A Players I.D Registration membership number & players name

Year Cards: Front – Must be year card colour – Signed and dated by the Regional Registration Officials and have Year of Affiliation as well as the players Name & EPA ID Registration membership Number & Inter-League team the player plays for in that season. If the player is a Non playing Member then 'No Team' is to be used in place of Team Name.

NB. Any incomplete, incorrect and/ defaced forms received by the Regional Registration Official will be returned to the County Official concerned without the players on those forms being registered.
